# TALUK LEVEL ACTIVITIES:

- SUGRAMA members of Gauribidanur taluk attended the meeting of PDOs wherein they also brought out the issues of the GP. The CEO has asked the PDOs to look at the issues and work towards resolving the same.
- SUGRAMA members with the partner organisations have also been working on collecting information pertaining to the President and Vice President in the wake of forced resignations in some GPs despite the amendment made.
- Members of SUGRAMA across all the taluks have been successful in helping the community in availing benefits through their GPs and also in submitting applications.
- As a redressal platform, members have been successful in resolving petty issues within the panchayat limits. This has helped them to be noticeable in their villages/panchayats.
- SUGRAMA members through the partner organisations have also been working on raising awareness on child marriage, malnutrition and VAW.
- Members are ensuring that Grama Sabhas are conducted in an effective manner.
- Members of SUGRAMA across all taluks have been associated with other platforms and associations and this has resulted in expanding the horizons of SUGRAMA.
- SUGRAMA members have also joined other networks and platforms and have participated actively in their pro grammes and meetings as well as awareness programmes
- SUGRAMA members were also successful in providing benefits and pensions to the old and needy. They also helped the community in speeding up the process of obtaining benefits without paying any commission to the officials.
- SUGRAMA members have been actively participating in the interface meetings, Need Based Workshops and federation meetings and raising issues affecting the community. The presence of resource persons under SBM, MGNREGA, etc. gave impetus to their functioning.
- There have been changes in the EC members in Gudibande and Gauribidanur taluks.
- Members have actively taken part in ensuring the developmental works under MGNREGA are provided to the job card holders. Issues have been taken up at the higher level.
- SUGRAMA members are personally visiting the anganawadi, schools, PHCs and so on and ensuring that the benefits are provided in an effective manner.
- SUGRAMA members have been successful in ensuring the formation of standing committees, SDMC committees and reformation of VHNC committees and ensured their presence in the committees.
- SUGRAMA was formed in Gulbarga (2 blocks) through the new partner of THP— Margadarshi Society
- A SUGRAMA member of Donagoan GP, Bidar received great applause from the officials and media for her participation in Janaspandana programme. The participation of EWR at Janaspandana was a welcome for effective functioning of EWRs.
- SUGRAMA members advocated for the installation of drinking water unit in their villages/GPs

## **STATE LEVEL ACTIVITIES:**

Upon the successful completion of the first Steering Committee meeting in June 2016, the Steering Committee members underwent an Orientation Programme in Bangalore between July 12-14, 2016. Prior to the conduct of the Orientation Programme, the members were asked to fill in the Need Assessment Forms beforehand to know their needs. The orientation programme primarily dealt with:

- The current status of SUGRAMA SWOT analysis
- The activities undertaken during the last three months
- At an individual level, how have there been a correlation/linkage between GP, Taluk and Zilla level
- Changed leadership how to understand it and make it create a positive impact and how to work towards other responsibilities
- As a state member, what is my role at the taluk and district level
- As a leader, how to look at inclusive growth and collective approach and sustain/strengthen SUGRAMA.
- Roles and responsibilities of members at the state level
- How to be a collective and how to sustain the collectivity
- Participation and empowerment of EWRs

The members were asked to perceive on:



These gave her a reflection on her part as State Steering Committee member. Renuka, former President of SUGRAMA was invited to give inputs to the current Steering Committee members.

#### MEETING THE RDPR MINISTER:

Some of the SUGRAMA members had been talking about the five year tenure and the GP Presidents asked to step down irrespective of the law made to give chance to another. SUGRAMA advocated for five year tenure during the last 7 years and the Government brought in an amendment to the clause increasing the tenure from 30 months to 5 years. However, inspite of the new amendments made, the GPs were seen forcing members to opt out of their President's post. Taking into consideration the issue where SUGRAMA is formed, discussions were held regarding the issue and a visit was made to Vidhana Soudha to meet the Minister for Rural Development and Panchayat Raj, Government of Karnataka. The Minister taking note of the issue mentioned of taking due action and forwarding letters to the GPs to protect the law and respect the amendments made.


